SMOA acknowledgments guidelines

Correctly acknowledging the scientific services is important for a number of reasons:

Recognize the efforts and motivate the technical staff: Recognizing everyone's efforts fosters a collaborative environment and ensures that everyone's work is appreciated. This, in turn, motivates the technical staff to maintain high standards and facilitates their professional advancement.

Highlight resources and enhance our center's reputation: Acknowledging the services utilized (specialized equipment, software, or expertise) showcases the resources and excellence of the CBM. This can enhance our reputation within the scientific community, attracting more researchers and potential collaborators.

E <u>Funding and support</u>: Thanking the scientific services for their work shows that their contributions and expertise are having a tangible impact on research and demonstrates that resources are being used effectively. This helps justify the funding provided and can be crucial for securing future funding or maintaining existing support.

<u>Transparency</u>: Services must also be accountable for the experiments conducted in our facilities. Ethical research practices require transparency about the resources and support that contributed to the findings. Recognizing the services is therefore part of the efforts to maintain integrity in research.
